WHEREAS, the recognition was granted to the institution namely, Krishna Cellege of Education for Women, Krishna Educational and Charit, Sakthinaikan Palayam Village, Elayampalayam, Namakkal, Tamilnadu-637205 run by Krishna Educational and Charitable Trust, Sathinaickanpalayam Village, Elayampalayam Tiruchengodu, Namakkal Tamilnadu vide SRC order No. F.SRC/NCTE/2009/M.Ed./RO/14569 on 15.07.2009 for conducting M.Ed. course of 1 year duration with an annual intake of 25 from the academic session 2009-2010.

- 2. AND WHEREAS, enhancement of intake of 10 seats from existing 25 to 35 is permitted vide Order No. F.SRO/NCTE/2010-2011/20625 dated 24.08.2010 to the institution for M.Ed. Course with effect from the session 2010-2011.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 22.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, revised provisional recognition order was issued to the institution on 22.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (one unit) from the academic session 2015-16.
- **4. AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue Show Cause Notice to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC, Show Cause Notice was issued to the institution on 16.09.2019. The institution has submitted reply on 13.10.2020.
- **5. AND WHEREAS,** the SRC in its 404th Meeting held on 16th & 17th November, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Krishna College of Education for Women, Survey No. 77/1C & 78/1, Sathinaickanpalyam Group, Elayampalayam Village, Tiruchengodu (TK), Namakkal District-637205 Tamil Nadu for M.Ed. programme for 1 basic unit of 50 students."

6. NOW THEREFORE, this order is issued permitting the institution i.e., Krishna College of Education for Women, Survey No. 77/1C & 78/1, Sathinaickanpalyam Group, Elayampalayam Village, Tiruchengodu (TK), Namakkal District-637205, Tamil Nadu sun by Krishna Educational and Charitable Trust, Survey No. 77/1C & 78/1,

Sathinaickanpalyam Group, Elayampalayam Village, Tiruchengodu (TK), Namakkal District-637205, Tamil Nadu for Continuation of recognition for M.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned.  - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.
